#### Sheila Jasanoff

is Pforzheimer Professor of Science and Technology Studies at Harvard University's John F. Kennedy School of Government. She has held academic appointments at Cornell, Yale, Oxford, Cambridge, and Kyoto. At Cornell, she founded and chaired the Department of Science and Technology Studies. She has been a Leverhulme Visiting Professor at the University of Cambridge, Fellow at the Berlin Institute for Advanced Study (*Wissenschaftskolleg*), and Karl Deutsch Guest Professor at the Berlin Science Center (*Wissenschaftszentrum*). Her research centers on the relationship of science and technology to politics and policy in modern democratic societies, with a particular focus on the uses of science in legal and regulatory settings. She has written and lectured widely on problems of environmental policy and the democratization of science in the United States, Europe, and India. Her books on these topics include *Controlling Chemicals* (co-authored, 1985), *The Fifth Branch* (1990), and *Science at the Bar* (1995). Her latest book, *Designs on Nature*, a comparative study of the politics of biotechnology in Europe and the United States, was published by Princeton in 2005. Jasanoff has served on the Board of Directors of the American Association for the Advancement of Science and as President of the Society for Social Studies of Science, whose J.D. Bernal award she received in 2004. She holds A.B., Ph.D. and J.D. degrees from Harvard University, and she received an honorary doctorate from the University of Twente in 2006.

#### Helga Nowotny

Current position: Vice-President of the European Research Council

Helga Nowotny is Professor em. of Social Studies of Science at ETH Zurich, Chair of the Scientific Advisory Board of the University of Vienna and member of the Governing Board of the Science Center in Berlin. Before joining ETH Zurich, she was Professor at the University of Vienna and Permanent Fellow at Collegium Budapest/Institute of Advanced Study. She has held teaching and research positions at King's College, Cambridge, the University of Bielefeld, the Wissenschaftszentrum Berlin and at the Ecoles des Hautes Etudes en Sciences Sociales in Paris. From 2001 – 2005 she was Chair of the European Research Advisory Board, EURAB, of the European Commission.

She has published widely in Social Studies of Science and Technology (STS) and in time studies. Her publications include *Re-Thinking Science* (with M Gibbons and P. Scott) and recently *Unersättliche Neugier: Innovation in einer ungewissen Zukunft*, 2005: *Curiosità insaziabile. L'innovazione in un futuro fragile*, 2006; *The Public Nature of Science under Assault* (co-authored), 2005; *Cultures of Technology and the Quest for Innovation.*
