13 Recommendations for R&I **Internationalisation**



Recommendation 1: Apply a clear intervention logic to substantiate international R&I cooperation strategies

Explore the use of a broad understanding of innovation, and operationalise it for the purpose of an inclusive and effective international R&I cooperation.

Recommendation 2: Reinforce strategic alignment of domestic policies to meet **R&I internationalisation rationales**

Ensure the strategic alignment of domestic instruments, programmes & regulations to meet the R&I internationalisation rationales stipulated in an R&I internationalisation strategy or roadmap.

Recommendation 3: Co-develop strategies

Co-develop a strategic R&I internationalisation concept, based on a clear intervention logic, together with the overall national R&I strategy, and integrate it there. Follow up with a dedicated R&I internationalisation roadmap, building on the strategy and further refining it. Include relevant stakeholders in these processes.

Recommendation 4: Implement effective cross-governmental coordination and multi-level participation processes

Organise inclusive multi-level participation processes to capture specific knowledge & interests of various stakeholders, identify opportunities for joint approaches & create synergies during the development & implementation phases of an R&I internationalisation strategy.

Recommendation 5: Secure sufficient resources for multilateral R&I coordination and internationalisation activities

Coordination between European countries is of utmost importance for a coordinated appearance at the global level. This should be strongly aligned with the European Commission and adequately supported by EU policies.

Recommendation 6: Monitor and evaluate international R&I cooperation policies

Jointly develop monitoring and evaluation standards in order to facilitate the assessment and comparability of international R&I cooperation activities, focusing on guidelines, surveys, etc.

Recommendation 7: Promote SDGs and challenge-driven R&I in international R&I cooperation

SDGs should be the starting point for joint agenda setting in challenge-driven international R&I cooperation. Joint approaches should be co-designed by EU Member States and countries associated to Framework Programmes.

Recommendation 8: Explore multi-stakeholder funding with private and third sector entities

International mapping and further networking among initiatives and learning platforms is needed to enhance practices of multi-stakeholder funding. Set up

a dedicated Task Force.

Recommendation 9: Valorise and operationalise science diplomacy for enhanced effectiveness

Cross-ministerial coordination should be strengthened to enhance the valorisation and operationalisation of science diplomacy. Offer training for prospective diplomats to better understand intersections of science, R&I and foreign affairs.

Recommendation 10: Invest in relationship management & stakeholder engagement

Develop systematic processes to engage with different R&I communities with an interest in STI agreements with specific partner countries. Invest in the relationship with STI agreement counterparts in the international partner country.

Recommendation 11: Establish joint action on 'good principles' in international R&I cooperation

Operationalise 'good principles' for ministerial or intergovernmental STI agreements and MoUs through a European consortium, involving experts, agencies and ministries responsible for international R&I cooperation.

Recommendation 12: Integrate foresight in national funding practices &

Conduct, at the international level, a study to learn from experiences of the use of foresight for international R&I programming. Different combinations of Member States and Associated Countries could start joint foresight initiatives.

Recommendation 13: Empower SFIC to play a more active role in coordinating joint R&I internationalisation activities

Increase the operational capability of SFIC (or any succeeding body) to perform its coordinating role in joint multilateral R&I cooperation activities between EU Member States/Associated Countries & selected international partner countries or regions.
