Gender roles, relations and inequalities have an impact on migration, influence who migrates and why, how the decision is made, and affect migrants

1 out of 35 people in the world is a migrant.


Half of these migrants in the world are women and 52% of internal migrants in Europe are women.

- Are the media providing an accurate image of female migrants?



POLICY- MAKERS

Yes, policy-makers can benefit from research findings.


A considerable number of research studies about Gender & Migration are stored in the depths of library databases and journals. Such studies are important for policy-making, but they are not sufficiently used. This is due to:

- lack of dialogue
- too much academic language
- difficulty of access to such documents

Who can benefit?

RESEARCHERS

Policy oriented research can have a significant impact on social well-being.

Researchers have produced a lot of highly policy-relevant knowledge on Gender and Migration.

Despite the value of this research the knowledge that is produced is not put into practice.

Can researchers benefit from contact with policy-makers?

Policy makers can and do use this knowledge gained through research to assess current policies and shape future ones which is a sign for the high recognition for the researchers' work. However this process is impeded by several factors:

- low visibility of research
- little contact between researchers and policy makers
- researchers and policy-makers speak different "languages".













