## RESEARCH AND INNOVATION POLICIES

Analysing and developing research and innovation (R&I) policies are core activities at ZSI. The department "Research Policy and Development" consults ministries and agencies along the whole research, technology and innovation policy cycle. We focus on R&D internationalisation, programme development, open science, evaluation and monitoring, policy management and the implementation of responsible research and innovation. Our team studies R&I systems on subnational, national and supranational level in regions as diverse as Central Europe and Southeast Asia.

Through these activities, our work provides relevant inputs for policy formulation and implementation, supports evidence-based policy making and includes impact assessments. We also organise networking activities that help various stakeholders to find a common ground for the development of joint strategies and undertakings and we continually support the EU's international research and innovation policy-making.
